

18<sup>th</sup> Annual Georgia Club Calf Producers Association Breeder Show and Board Bid off Sale  
April 7, 2018  
Tifton GA

1. The Show/Sale will be held on Saturday April 7 in Tifton GA. The show will start at 9:00am Eastern time.
2. The show and sale will consist of no more than 50 steers and heifers total. You can enter no more than (2) head. If we do not meet our goal of 50, the consigners may enter 1 more calf.
3. Cattle may begin arriving at the sale/show site at Noon on Friday April 6 2018. All cattle must be checked in by 6pm April 6 2018. Check-in will consist of recording tattoo (**Be sure calves are tattooed before you get to the sale**), and ear tagging with a lot number (GCCPA ear tag).
4. All calves must be in show and sale condition, if cattle are not in show and sale condition, the calves will not be allowed to show or sale. This will be decided by the executive committee.
5. **You may not bring cattle that are not consigned to the sale. If you are bringing pre-sold cattle to drop off to a buyer, they must stay on your trailer.**
6. All cattle must be bred and consigned by GCCPA members. Current 2018 GCCPA membership dues must be paid by March 1, 2018.
7. **A NON-REFUNDABLE one time show and sale fee of \$100 fee per calf must be postmarked by March 16, 2018 at the time of nomination. (this includes show premiums, sale flyers, postage) (NOT membership or tags)**
  - **Steer show(\$250 Champion and \$200 Reserve if funds allow, May be more)**
  - **Heifer show(\$250 Champion and \$200 Reserve if funds allow, May be more)**
  - **Bred heifer show( for anyone with a GCCPA bred heifer that would like to show and sale)**
  - **Embryo packages**
  - **Must be GCCPA calves**
  - **This will be a fit show**
  - **Cattle will receive double point from the show (will extend to the new owner)**
  - **Board bid sale (closing 1 hour after the show ends)**
8. All calves must be born no later than November 2017 for this sale. It is suggested that all cattle are weaned and on feed no later than March 1, 2018.
9. After all nominations are received, the sale committee will reserve the right to come up with a plan to get the show/sale numbers to no more than 50 head. This plan may include a screening process.
10. The breeders of the animals are responsible for their bid off (if the breeder needs help a member of the executive board will provide help.)
11. Calves will be floored at the breeders discretion, cattle may have bids on them at their arrival at the show and sale.
12. All calves must have been owned by the consigner. No purchased calves are allowed in the show and sale. However, if you purchased a cow from another GCCPA member and she calved on your farm – that animal is eligible. Or if you purchased an embryo from another GCCPA member and it was born on your farm – it is eligible.)

13. *Consigners must supply a new black rope halter to be sold with each calf.* (Note: this is different from year's past. The sale management will not be supplying halters!)
14. A show/ sale sheet listing the sale order (by lot numbers), tattoo, birthdate, breed make-up, weight, and breeder will be available in good quantity on sale day for use by potential buyers. Calves will be tagged with the official GCCPA tag which will be the lot number.
15. Checks or payment will be made out to the seller of the calves and collected by the GCCPA the day of the sale. The sellers will assume the responsibility of any collecting, including non-sufficient funds, after sale day. Cattle will not be loaded without conformation of payment
16. Any consignor not abiding by all the rules of the sale may not be allowed to participate in the future GCCPA sales and will forfeit their GCCPA membership.
17. The Sale Committee (which is made up of the current GCCPA Board of Directors) reserves the right to make any interpretation of these rules and to add any rules or procedures that benefit the sale or consignors as a whole. Also the committee will be the final say on any situations that may arise concerning the sale.
