Contest Check-in will begin at 9:30 a.m. at the Greene County Expo Center which is located next to the Greene County Extension Office.

The contest will begin promptly at 10:00 a.m.

- A. Open to all 4-H and FFA members. All 4-H and FFA members will be scored as individuals. Team Scores will not be tabulated. Participants will not be separated by organization.
- B. Junior division will be comprised of all individuals from 4th to 8th grade. Senior division will consist of all individuals from 9th to 12th grade. Grades defined as of September 1st of the current year.
- C. Registration entries and including fees must be postmarked by **February 11, 2019, to qualify for Early Bird.**
All entries received after that date, through registration cut-off date of Wednesday, March 6, will be classified as Late Entries, with fees due of \$25.00
- D. Contest entry fee is \$15 per competitor. Late entries will be \$25.
i. Entry fees include lunch for each competitor.
ii. T-shirts will be sold for \$5 each and are PRE-SALE ONLY.
iii. Late entries will not receive a shirt.

- I. Two minutes will be allowed to give oral reasons on each class. Contestants will be allowed fifteen (15) minutes on each class, to make their observations, take notes, and fill out their placing card.
- J. Classes and designated reasons classes will be announced at orientation.
- K. Senior division will give two sets of reasons. Junior division will give one set of reasons.
- L. Committee critique will follow reasons.
- M. Results and awards ceremony will follow the committee critique.
