1. Show is open to all FFA & 4-H members ages 9 to the 12th grade.
2. Exhibitors are responsible for their own animal and assume all risk. The Stephens County FFA Alumni or anyone associated with the show will not be liable for any accidents, injury or theft
3. Health papers will be required.
4. Original registration papers must be presented for all registered heifers.
5. Registered heifers will be shown by birthdate and breed. **NEW** - In order to qualify as a breed show there must be 4 heifers of that breed entered in the show. Those with less than 4 will show in all other breeds (AOB).
6. Commercial heifers will be shown by weight.
7. Market Steers and Heifers will be shown by weight.
8. The show order for showmanship and classes will be determined after all entries are received.
9. The Judge's decision will be final.
